This LOP will run coterminous with the Frame Agreement on a prospective basis from the enrollment date, including any extensions and/or amendments thereof. If the Frame Agreement expires or is terminated, this LOP will expire or terminate with no need for action by either party unless Supplier and Member enter into a signed written amendment to this LOP that provides otherwise.

Either party may terminate this LOP for any reason upon 30 days' written notice to the other party. In the event of a termination, Member understands they will no longer be eligible for pricing, discounts, or any other contract benefit under the Frame Agreement.

The Member agrees that all MRO product purchases by the Member from MSC will be subject to the terms and conditions set forth in the Frame Agreement and MSC's standard terms and conditions found on www.mscdirect.com, and should there be a conflict between the Frame Agreement and MSC's standard terms and conditions, the Frame Agreement shall control.

Each party will protect and not disclose any non-public information received from the other in connection with this LOP, except with prior written authorization or as required by law. Such information may be used only for purposes of the parties' business relationship. MSC may provide customized or specific product, pricing, and related commercial information ("MSC Data"), and MSC retains all rights in MSC Data. Member shall keep MSC Data strictly confidential and use it solely for Member's internal business purposes relating to the purchase of MSC products. Member shall not disclose or use MSC Data for any other purpose, including listing MSC products on third-party websites or online marketplaces. These confidentiality and restricted-use obligations will continue for three (3) years after termination of this LOP
